School Business:

Block Schedule Discussion

- We have great programs and want kids to have the opportunity to take many different electives.
- Digital Literacy is a new required course that can be taken in 7th or 8th grade.
- Block schedule requires great teaching and teacher's need to revamp lessons to fit an 80-minute schedule.
- 2/3 of our students take a full 1.0 elective class
- ½ of our students take two full 1.0 elective classes- this will not work with the implementation of Digital Literacy for either our 7th or 8th grades depending on when Digital Literacy is taken.
- Pros:
 - Increased options for electives
 - Solves Digital Literacy's impact
 - Makes it easier for students to fulfil Regents Scholarship requirements
 - o More time for in depth lessons that promote deeper learning
 - Teacher prep time 80 minutes per day-more prep time for teachers is good for learning

- Teachers able to teach a productivity period while still having preparation time every other day –this helps meet the needs of the school for making the master schedule
- Less stress for kids with fewer classes per day and more time to complete homework.
- o Better attendance
- o Research shows no negative impact on learning

• Cons:

- Class size (Average case load would be 36 kids/class. On a 7 period schedule it would be 31 kids per class.)
- o Case load (On a 7 period schedule 186 kids and 8 period schedule 216 kids.)
- Would lose 5 min. of class time a day teachers feel this would be mitigated by increasing efficiencies-less transition time (set up/take down) etc.
- o Professional development may be needed to help teachers with the transition.

Teachers have reviewed this issue and have voted in favor of moving to a Block Schedule by a margin of 30:4
