Dan Linford is focused on kids and schools. Mr. Linford talked about SEL. Have teachers greet students. It is powerful when they feel welcome. He wants them to feel safe so learning can happen. Wants affirmations of learning. He talked about the book committee. He talked about the DOJ report: create new policy, reporting system, and better communication. He is working on systemic systems that work for our kids and loving them. He talked about respect for teachers and having them feel supported.

- 5. Library Book Committee Update Rachelle Sagers & Jeanette Moore
 - Have a list of things that the committee needs to be looking for. There is a mission statement. Make sure they meet all the sensitive information laws. Went through the list of books that have not been checked out in 15 years. This policy is for library books not for textbooks used in classrooms for curriculum.
 - Tiffany Tueller served on the social studies committee. There was bias and one-sided stories that were incorrect. Make sure all stories are told correctly.
 - Mr. Cawley talked about his experience about teaching English in Vietnam, and one-sided information being taught that is incorrect. Mr. Chapple assured Mr. Cawley that the USOE is working with the legislature.
 - Teachers must disclose all books that students will be using in the classroom.
 - There is a process where parents can remove access for their children to certain books.
 - Mr. Chapple said that parents can check their guardian accounts to see what books they have checked out.
 - Mrs. Moore talked about what a great job Mrs. Weideman is doing in the library.

8. Data Review – Brad Chapple

- Mr. Chapple met with a data specialist at the district, Jon Hyatt.
- Mr. Chapple could only see sub scores in Power Bl.
- Mr. Chapple showed the CC the Data Gateway page from the State. ("data gateway" at Utah.gov, select schools, select MJH – compare school and data proficiency reports are available and show great information)
- MJH received a "B" grade, but we are close to getting an "A" and that is our goal.
- Can pullout demographic information and compare to other schools that are similar.
 There are six schools that are out performing us in math. BJH is one of those schools.
 They have math every day. How are they teaching math there? Then we looked at growth. KJH has great scores. What can we learn from them? We are waiting for the data to be broken down by grade level.
- Over the summer our math teachers went to summer training. Teachers are working on some new teaching strategies. Mr. Chapple is working on bringing on board all the math teachers to these new strategies. We want to grow by 5 points each for the next two years.
- Parents need resources for helping their children at home. There is going to be a new textbook in the math classrooms. Teachers need to be transparent with parents and communicate. Parents don't do math the "new" way, and parents need resources to help. Some new textbooks have "Notes to parents."
